Matching Gifts to Charitable Organizations

Charitable organizations must confirm matching gift request within 60 days of online gift submission in order to be eligible to receive the Foundation match Eligible Methods of Payment Any gift must be a minimum gift of \$25 US dollars, and the maximum to be matched is \$1,500 US dollars per calendar year/per participant

States estate and gift tax on their worldwide assets, whether through lifetime gift or passing at death The United States is a party to a number of estate and gift tax treaties , whereby double taxation is avoided, typically on real estate
